Gerald and Jodie Cappelli 6655 E Quaker St. Orchard Park, NY 14127 SBL #172.16-1-19

1. Applicant is requesting a variance to Municipal Code Section 225-11, C1

Applicant is requesting permission to construct a covered rear porch at 6655 E Quaker St. in a required yard. The code stipulates that every part of a required yard must be open to the sky unobstructed.

- 2. Applicant is requesting a variance to Municipal Code Section 225-12(F)1(a,c,e). Accessory Structures in R-Districts.
 - a. Applicant is requesting permission to construct an Accessory Structure in an R-1 zone. The resulting structure will have an area of 720 sq. ft. The code stipulates that an structure exceeding 600 square feet in an R-1 zone must be considered a principal structure.
 - b. Applicant is requesting permission to construct an Accessory Structure with a structure height of 26 ft. and have two (2) stories. The code stipulates that an accessory building shall not exceed one story and 14 feet in height and that only one principal building is permitted on a lot of record in an R-1 zone.
 - c. Applicant is requesting a side yard setback of 2'6" and 4'6" for the Accessory Structure. The code stipulates an 8' side yard setback is required.
- 3. Applicant is requesting a variance to Municipal Code Section 225 Schedule II

Applicant is requesting a 2'3" side yard setback to erect a covered porch off the rear of the house. The code stipulates an 8' side yard setback is required.

Daryl Martin, Architect

Applicant indicated he would eventually like to expand the sewer for the property. The Accessory Structure would never be used as a living space and will not block the neighbor's view.
