For district users - a rate of \$9.37 per one thousand gallons plus an O&M quarterly charge of \$9.81; the minimum quarterly water charge being \$75.40 for seven thousand gallons.

For non-district users - a rate of \$13.12 per one thousand gallons plus and O&M quarterly charge of \$43.70; the minimum quarterly water charge being \$135.54 for seven thousand gallons.

BE IT FURTHER RESOLVED, unpaid charges shall be enforced as provided by Chapter 210 of the Municipal Code of the Village of Orchard Park.
